A meeting of the Coordinating Council of the Learning Community of Douglas and Sarpy Counties was held January 3, 2019, at the Learning Community Center of North Omaha, 1612 N. 24 Street, Omaha, Nebraska 68110. Notice of the meeting, containing the date, time, place and agenda, was given in advance thereof by publication in the Daily Record on December 26, 2018. The proofs of publication have been received and will be made a permanent part of the record of the meeting. Notice of the agenda was given to all members of the Council on December 28, 2018.

- 1. **Call Meeting to Order**. The meeting was convened and called to order by Vice Chair Kelley at 6:00 p.m. and began with the recitation of the Pledge of Allegiance.
- 2. Public Notice & Compliance with Open Meetings Act. Vice Chair Kelley announced that the Nebraska Open Meetings Act was posted at the room entrance and that copies of materials being reviewed by the Council were available to the public.
- 3. Oath of Office / Swearing in of Council Members Ms. Hershiser administered the Oath of Office to the following Learning Community Coordinating Council members: Bradley Ekwerekwu, Brian Thommes, Mark Hoeger, Melinda Kozel, Anayeli Martinez-Real, Tonya Ward.

#### 5. Welcome and Introductions

Chair Kelley was confirmed by majority roll call vote as Chair of the Coordinating Council.

Vice Chair Kelley nominated Mr. Hager for the position of Vice Chair of the Coordinating Council. No further nominations were received and nominations were closed after three calls for nominations. Vice Chair Hager was confirmed by majority roll call vote as Vice Chair of the Coordinating Council.

Mr. Patton opened the floor for nominations for the position of Secretary of the Coordinating Council. Chair Kelley nominated Jill Woodward for the position of Secretary of the Coordinating Council. No further nominations were received and nominations were closed after three calls for nominations. Jill Woodward was confirmed as Secretary of the Coordinating Council by majority roll call vote.

Mr. Patton opened the floor for nominations for the position of Treasurer of the Coordinating Council. Mr. Hager nominated Carol Hahn for the position of Treasurer of the Coordinating Council. No further nominations were received and nominations were closed after three calls for nominations. Carol Hahn was confirmed as Treasurer of the Coordinating Council by majority roll call vote.

# **Pilot Program Funding**

Requested Actions: Increase pilot program funding by 3% and distribute funding according to existing formula

#### Background & Scope:

In addition to the establishment of Elementary Learning Centers and the Superintendents' Early Childhood Plan, the Learning Community allocates some funding for all districts to provide pilot programming. The past few years, the Elementary Learning and Diversity (ELD) Subcommittee has spent a considerable amount of time determining which types of pilot programs to consider for funding and supports Extended Learning, Jumpstart to Kindergarten and Instructional Coaching programs. Districts are also given the opportunity to propose other programming.

#### **Allocation Process**

In partnership with districts Subcouncils 1,3 4 and 6 have agreed to divide the appropriated funding using a formula of 80% Free and Reduced Lunch (FRL) and 20% English Language Learners (ELL). Additionally, Subcouncil 5 has allocated a portion of the elementary learning center funding in South Omaha to Bellevue Public Schools. This year, the Budget, Finance and Audit Subcommittee is recommending a 3% increase.

#### **Agreement Process**

Staff works directly with each of the school districts to figure out which programs to support. Subcouncils informally approve the programs in advance so districts can be most efficient with the required paperwork. Subcouncils then schedule formal meetings to discuss and approve the program agreements and bring such to the full Council in May. We continue to receive very positive feedback from districts who have greatly appreciated the opportunity to plan ahead of time and work together to best meet the needs of children in poverty. An attached timeline has been provided.

#### **Two Year Agreements**

Districts in Subcouncils 1, 3 and 5 are entering the second year of a two year agreement so no action is necessary in terms of recommending a program. However, districts would like to meet with the new Subcouncil members to share more information about their programs and answer any questions. Staff will arrange these meetings in February and March.

# PILOT PROGRAM AGREEMENT PROCESS 2019

**Process Overview:** The past few years, the ELC Subcommittee has spent a considerable amount of time determining which types of pilot programs to consider for funding and recommended supporting Extended Learning, Jumpstart to Kindergarten and Instructional Coaching Programs. Subcouncils then ask staff to work directly with the districts to figure out which programs to support and how much to allocate to each district ahead of time. Each Subcouncil informally approves the program and dollar amounts in advance so that districts could be most efficient with the required paperwork. Subcouncils then schedule formal meetings to approve the program agreements, and bring such to the full Council in May. We continue to receive very positive feedback from districts who have greatly appreciated the opportunity to plan ahead of time and work together to best meet the needs of children in poverty.
