### Summer Academy 2021 Learning Community Center of South Omaha

This summer was the first where both centers piloted a Summer Academy, which focused on remedying the COVID slide and building Kindergarten skills.

At the South Center, classes were held on Monday – Thursday, with a morning and afternoon session. Parents studied English while their children were in Summer Academy. The month of June was successful and had good attendance, but the rate lowered significantly during the month of July, which is traditionally a month with low attendance. (The South Center has had summer programming since 2012, except for 2020.) Some children enrolled during July attended only occasionally. Many families had older children at home who could not participate in the program this summer due to space and staffing concerns. After it was clear that there was capacity for more children in July, seven additional five and six-year-olds were allowed to attend after the first week of July.

The center partnered with Opera Omaha's Community Fellowship program, which visited the center with two opera singers to engage the children with activities related to literacy and the performing arts. The Salvation Army also had a food truck on-site called the Kids Crusin' Kitchen, which provided daily free meals for the children in the program.

Monroe Meyer Institute conducted the Minnesota Executive Functioning Scale (MEFS) with preschoolaged children at the beginning of June and the end of July. Twenty-two children were pre-tested in June, and ten were post-tested in July.

### **Summer Academy 2021 Learning Community Center of North Omaha**

At the North Center, classes were held Monday through Fridays 7:30 am to 8:00 am breakfast was provided, and instruction began at 8:00 am and ended each day at 12:00pm. A light lunch was also sent home daily with each child. Summer Academy was held starting June 2<sup>nd</sup> to June 30<sup>th</sup> and July 6<sup>th</sup> through July 23<sup>rd</sup> a total of 35 instruction days. There were six children who attend from June to July. The children were dropped off at the North Center and greeted and temperatures were checked daily. The children remained onsite daily without their parents' presence. Summer Academy began with 8 total children ages 3- and 4-year-old boys and girls. It was a multi-cultural group of Black, Hispanic, Somali, and Russian children. By the end of the second term there were 6 (5 boys and 1 girl) remaining that could commit to daily attendance.

The North Center partnered with Kids Squad to provide the Summer Academy. The North Center is usually very slow and pre-COVID planned literacy activities for families would occur during the summer months. This year the summer was focused on providing language and literacy for the children as well as social emotional skills in preparation for starting school soon. The staff spent time working with the children to expand their vocabulary by using specific words for people, places, things, and actions. They also used descriptive words while the children participated in routines and play and then encouraged children to further develop thinking skills by asking them questions. Staff read books and the librarian did a weekly story-time that would include some physical activities such as singing and dancing. Staff promoted use of both fine and gross motor skills through play with blocks and drawings using paint. Social skills were encouraged and when conflicts happened the staff would assist the children with resolving them. The staff taught the children about personal care routines and safety practices.

Monroe Meyer Institute conducted both the pre and post MEFS assessment for all 6 children that attended and completed Summer Academy. The Spanish speaking child was given the BATERIA assessment. The Pre was done during the first week of Summer Academy and the Post completed during the final week.

Overview

Learning Community has long been committed to demonstrating and replicating innovative family learning programs in the Learning Community Center of South Omaha to meet the critical needs of children and families in poverty.

Three years ago, the building next door became available for rent. The main area was designed to accommodate the growing needs of the program. The basement of this building was not in the best shape. OneWorld offered to renovate and sublease the basement for a minority health program. This space is no longer needed and is available to us.

#### **Supporting Detail**

Learning Community has carefully reflected on specific feedback from the third party evaluation as well as parental and staff input in order to ensure continuous program improvement. As a result, one parent classroom has been used for children in the main center in response to both COVID concerns as well following best practices in early childhood education. In order to have three classrooms of parents onsite at the same time, a dedicated classroom space for parents is currently being added in the Annex building.

While this change is beneficial for parents and children in our program, it leaves staff without meeting and planning space as well as the location they used to visit privately with families. By assuming the cost of the sublease, Learning Community staff would have ample and dedicated space for meetings and planning. It would also allow space for navigators to meet privately with families onsite.

#### **Budget and Recommendation**


The additional annual cost would be \$8,400 and is available within the current capital budget.



#### Learning Community Center of South Omaha Annex (El Mero Mero) Basement Need



Classroom C in the main center became a child classroom during the past year. This was both due to the pandemic and best practices in early childhood education, as our childcare rooms become quite crowded at times. This room is still being furnished, but was used this summer during Summer Academy.



Since one of the parent classrooms in the main center is being used for childcare, the front room of the Annex is currently being renovated to become a classroom. This will be complete sometime early this fall.



The Annex basement has been subleased for the past three years by OneWorld for their minority health team. Now that the front room upstairs is no longer available for navigator/participant meetings, teacher planning space, practicum student workspace, etc., the basement is now needed for center operations.

#### Overview

The UNMC/MMI Evaluation scope of work covers the evaluation of programs funded through the Elementary Learning Center funding stream including all programming at both of the Learning Community Centers as well as pilot programming across multiple districts (Kindergarten Jumpstart, Extended Learning Programs and Instructional Coaching). Having an independent, third-party evaluator document the sustained success of programming is essential to the Learning Community's mission of demonstrating improved practice to measurably improve student learning.

#### **Supporting Detail**

Our partnership with the UNMC/MMI as our third-party evaluator continues to be successful. As most will recall, the legislature not only asked us to provide independent evaluation for our programming and this contract has delivered well in meeting that need to provide summary data appropriate for policy makers. The principal investigator of the evaluation, Dr. Jolene Johnson, will provide support to the Council members and Learning Community staff.

#### **Current Results**

We are very fortunate that MMI shares with the Learning Community the value of utilizing the Continuous Improvement Model with is provided by MMI staff. Through this model, MMI staff provide real time evaluation feedback to providers which are then incorporated into the existing program for improvement. Feedback from both school districts and community agencies has been extremely positive.

#### **Budget & Recommendation**

The amended contract is recommended for one year for \$421,975. While the budget includes additional child level assessments to accommodate the expansion of Parent University and longitudinal data analysis, it is nearly 4% lower due to Dr. Jackson's retirement and removal of the CLASS as a tool for measuring the success of Instructional Coaching.



#### SECOND AMENDMENT TO EVALUATION AGREEMENT

THIS SECOND AMENDMENT TO EVALUATION AGREEMENT (this "Second Amendment") is effective August \_\_\_\_, 2021 (the "Effective Date") by and between the Learning Community of Douglas and Sarpy Counties, a Nebraska political subdivision (the "Learning Community"), and Board of Regents of the University of Nebraska, for and on behalf of University of Nebraska Medical Center, a Nebraska political subdivision, on behalf of the Monroe-Meyer Institute for Genetics and Rehabilitation ("MMI" and collectively, "UNMC").

#### RECITALS:

WHEREAS, the Learning Community and UNMC are parties to that certain Evaluation Agreement entered into by and between the parties and effective as of September 1, 2020, as amended by that certain First Amendment to Evaluation Agreement by and between the parties (collectively, the "Agreement");

WHEREAS, under the Agreement, the Learning Community engaged UNMC to conduct the CAP evaluation and program evaluation services for the ELC Programs;

WHEREAS, pursuant to Section 2 of the Agreement, the parties desire to work cooperatively on a new Project and to set forth a new Plan and Term Amount for the period of September 1, 2021 through August 31, 2022; and

WHEREAS, pursuant to Section 21 of the Agreement, the parties hereby amend the Agreement in accordance with the terms and conditions set forth in this Second Amendment.

NOW, THEREFORE, in consideration of the mutual promises contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

- 1. <u>Defined Terms</u>. All capitalized terms contained in this Second Amendment that are not otherwise defined herein shall have the meaning ascribed to them in the Agreement.
- 2. <u>New Plan and Project Fee</u>. The parties agree to the new Project and new Plan, with a Term Amount for the scope of services related to the same not to exceed \$421,975 as detailed on the sequentially numbered Exhibit "2" attached hereto ("Exhibit 2").
- 3. <u>Performance Period</u>. The Term of the Agreement shall be extended to, and continue for a twelve (12) month period until, August 31, 2022, unless earlier terminated as provided in the Agreement.

#### 4. Payment and Billing.

- a. The parties agree that the reference to "Exhibit A" in Section 4 shall be replaced with "Exhibit 1 (or the sequentially numbered Exhibit for the applicable Project(s) and Plan)."
- b. The parties agree that the reference to "October 5, 2020" in Section 4(a) shall be replaced with "October 5, 2021."
- 5. <u>Exhibit</u>. Exhibit A of the Agreement is relabeled to Exhibit 1.
- 6. <u>Conflict of Terms</u>. In the event of a conflict between the terms and conditions of the Agreement and this Second Amendment, the terms and conditions of this Second Amendment shall apply.
- 7. <u>Ratification and Reaffirmation</u>. The parties do hereby ratify, reaffirm, adopt, contract for, and agree to be or continue to be, as the case may be, bound by all of the terms and conditions of the Agreement. Except as modified herein, all of the terms and conditions of the Agreement are incorporated

by reference herein as if set forth at length. It is acknowledged and agreed that the execution of this Second Amendment by the parties is not intended to and shall not constitute a release of the parties from any and all obligations or liabilities which they have to each other under and pursuant to the terms of the Agreement, and the parties are not released from any such liabilities or obligations.

- 8. <u>Integration</u>. The Agreement together with this Second Amendment, including the recitals to this Second Amendment, each of which are incorporated herein by this reference, constitutes the entire agreement of the parties relating to the subject matter hereof, and supersedes any prior agreements or understandings, written or oral, between the parties with respect to the subject matter hereof.
- 9. <u>Counterparts</u>. This Second Amendment may be executed in any number of counterparts and by the parties hereto on separate counterparts, each of which, once executed, shall be deemed an original, but all counterparts shall constitute one and the same instrument.

#### Scope of Work:

- The scope of work covers the evaluation of programs funded through the ELC funding stream, including school and family support initiatives and projects. MMI staff will work individually with funded sites to develop an appropriate implementation of the overall Learning Community evaluation plan.
- The MMI Principal Investigators will work with the Learning Community to implement the work scope as outlined in the logic model.
- All results will be synthesized and reported for Learning Community Leadership Staff and council members. Schools will also provide administrative and outcome data for use in the evaluation.
- Develop an evaluation framework for 2022-2023 involving multiple stakeholder groups. This task will
  include focus groups, listening sessions and interviews to determine evaluation questions,
  measures, and methods for the following year.
- Conduct longitudinal analyses and present findings to the Learning Community Leadership team and council members.

#### External evaluation:

- o Jump Start to Kindergarten. MMI staff will utilize the Bracken School Readiness Assessment pre and post with all students to measure the impact of programming on students preparing to enter kindergarten. Results will be synthesized and reported for Learning Community Leadership Staff and sub-council members. Parent surveys will also be collected, analyzed, and reported. A kindergarten teacher survey will be administered in the fall to determine the extent the Jump Start Program supported the students' readiness to entering kindergarten.
- Extended Learning. Parent surveys will be collected, analyzed, and reported. Student level achievement data will be requested from districts and then analyzed.
- Learning Community Center of South Omaha. MMI staff will work closely with LCCSO to collect adult and child participant data (focus groups with parents, parent surveys, administrative data, adult (e.g., CASA), parent-child assessments (e.g. KIPS) and student assessments (Bateria, MEFS). Data will be collected from participants at LCCSO.
- Learning Community Center of North Omaha
  - Intensive Early Childhood Program (At Kellom, Conestoga, Lothrop, Franklin, Minne Lusa and Skinner.
    - PreK Classroom Observation tools: Classroom Assessment Scoring System (CLASS) will be used for veteran teachers. This tool focuses exclusively on teacher-child and child-child interactions within the classroom.

- Child Outcomes:
  - Devereux Early Childhood Assessment (DECA) will be used to measure children's social-emotional development.
  - Minnesota Executive Function Scale (MEFS) will be used to measure children's executive functioning skills
  - Peabody Picture Vocabulary Test (PPVT) will be used to measure children's receptive vocabulary
  - Bracken School Readiness Assessment (Bracken) will be used to measure children's readiness for kindergarten
- Focus group and/or surveys will occur with coaches, teaching staff and/or principals.
- Family Navigators: Review of service plans by UNMC LCSW to examine quality, goals and progress of families. Feedback is provided twice per year to the service providers and supervisor(s).
- Parent University: analyses of family data (e.g., surveys, administrative data, and KIPS, course outcome data as relevant), child data and focus groups.
- Partnership with higher education: Reporting on graduate survey data and focus group data.
- Child Care project: Completion of family childcare observations, pre/post knowledge assessment, and focus groups.
- Literacy and/or Instructional Coaching. MMI staff will collaborate with area schools implementing an Instructional Coaching Model (Bellevue, Millard Omaha, Ralston and Westside). Locally collected administrative data will be used to measure student progress (e.g., AimsWeb, MAP, Accuity, and NeSA). Focus groups and/or survey data will be conducted with staff in the spring to evaluate the implementation of literacy coaching (coaches, teachers).

#### Administrative Activities:

- The MMI Principal Investigators will participate in the Learning Community Evaluation Management Team meetings (approximately monthly).
- The MMI Principal Investigators will work with the Nebraska Department of Education and districts as applicable to collect student demographics and assessment data including NWEA-MAP and the statewide assessment scores.
- The MMI Principal Investigator and her team will also serve in a planning role with regard to developing birth to five programs across the LC.
- MMI staff will collaborate with members of individual districts to obtain approvals including district research requests, where applicable.
- MMI staff will analyze all observation, participation, demographic, and survey data and prepare an Annual Evaluation Report to be submitted to the Executive Director November of each year.
- PIs will co-present at national and local conferences as requested.

#### Personnel:

J. Johnson, Ed.D. (.20 FTE) and R. Zweiback (.10) co-PIs will be responsible for developing, overseeing, and implementing the evaluation plan for all programs funded by the Learning Community of Douglas and Sarpy Counties' Elementary Learning Centers funding stream. They will supervise the evaluation staff in data collection and debriefing activities. They will also be responsible for overseeing data

collection, data analysis, dissemination of formative and summative findings, participation with the Evaluation Collaborative member group, and completion of identified reports.

- A. Encinger, Ph.D. (.20) will lead the childcare evaluation and be the lead statistician for the annual and longitudinal analyses.
- K. Price (.45) and A. Mills (.35) Project Leads will assist in the evaluation of the project, data collection, and will be responsible for coordinating a component of the evaluation project.
- A. Siebler, K. Tourek, S. Baird, J. Harmon, J. Rodriquez, C. Villanueva, N. Buchholz, K. Dietrich, Y. Estrada, C. Butler, J. Finkle, B. Zessin, and a TBD Bilingual Evaluator (2.95 FTE) will assist in evaluation of the project including conducting focus groups, collecting child and family data, and completion of classroom observations.
  - J. Biodrowski, Data Entry (0.15)—will be responsible for data entry.
  - M. Young-Oestmann, (.25 FTE) will be responsible for day-to-day administrative tasks.

<u>Fringe Benefits</u>: University benefits include contributions to health insurance, life insurance, retirement, and social security.

<u>Travel</u>: This will include local travel to assist in site visits and to attend meetings as identified and travel for presentations.

<u>Supplies/Equipment</u>: Supplies will include general office supplies and assessment materials (Bracken SRA kits, assessment protocols, CLASS protocols, CASA and online reliability processes). Equipment will include video recording cameras, computers and office furniture as needed.

#### Operating:

Contractor Travel: Will cover costs to travel to sites to complete the evaluations.

MEFS Contract: Fees for MEFS online protocols.

<u>Fees for certifications</u>. Will include payments for staff members to obtain and maintain reliability on the Pre-K, K-3 CLASS and KIPS certification. Includes training on the newest version of CASA.

<u>Incentives</u>. Will be gift cards to pay teachers and childcare staff to participate in focus groups and complete assessments.

<u>Copy and Print</u>: Will be used to make copies of materials for site reviews and meetings and funds to support the printing of reports.

<u>Telephone</u>: Will be used to support costs of webinar, conferencing, surveying and telephone support for ongoing coordination with local sites and the Learning Community.

<u>Administrative Costs</u>: This will include support for ongoing administrative support, computer maintenance, information technology, and accounting support for business and other administrative activities related to the contract.



#### % of Students Experiencing Poverty







